## Coronavirus – Local Update 19

4 TH APRIL 2020

### Current overview (subject to change or variation):

- We are aware that people are congregating in open spaces across the tri-borough area. To keep people safe, we have diverted officers from other duties by patrol these areas, engage with them, explain why they should not congregate, and encourage them to leave. We maintain that enforcement is an option we will use if it continues.
- We adopt a graduated response to using the new policing powers, with enforcement action only taking place where other less intrusive options have failed or are likely to do so in the circumstances
- Since the Government has introduced stringent conditions the MPS policing style to help enforce these conditions should be graduated as follows:
  - Enhanced visibility in our communities
  - Engagement and encouragement to adhere to Government direction
  - o Support to Local Authorities in enforcing premises closure
  - o Issue of Fixed Penalty Notices where a power exists and is appropriate
  - Use of powers when necessary and as a last resort.
- The Met, and London is extremely resilient. Our officers are, and will continue to be out on the streets and supporting communities.

As of 1500hrs, 4<sup>th</sup> April 2020 the advice is:

### STAY AT HOME TO STOP CORONAVIRUS SPREADING

- EVERYONE must stay at home to help stop the spread of coronavirus.
- You should only leave the house for 1 of **4 reasons**:
  - Shopping for basic necessities, for example food and medicine, which must be as infrequent as possible
  - One form of exercise a day, for example a run, walk, or cycle alone or with members of your household
- **Any medical need,** including to donate blood, avoid or escape risk of injury or harm, or to provide care or to help a vulnerable person
- Travelling for work purposes, but only where you cannot work from home

### Important

**These reasons are EXCEPTIONS** – even when doing these activities, you should be minimising time spent outside of the home and ensuring you are 2 metres apart from anyone outside of your household.

If you need medical help for any reason, do not go to places like a GP surgery, pharmacy or hospital.


