Launch of 'Streetspace' Plan (6th May 2020)

The Mayor of London, Sadiq Khan, and TfL have today unveiled their 'London Streetspace' programme which will rapidly transform London's streets to accommodate a possible ten-fold increase in cycling and five-fold increase in walking when lockdown restrictions are eased.

With London's public transport capacity potentially running at a fifth of pre-crisis levels, millions of journeys a day will need to be made by other means. If people switch only a fraction of these journeys to cars, London risks grinding to a halt, air quality will worsen, and road danger will increase.

To prevent this happening, TfL will rapidly repurpose London's streets to serve this unprecedented demand for walking and cycling in a major new strategic shift.

The Mayor of London, Sadiq Khan, said: "The capacity of our public transport will be dramatically reduced post-coronavirus as a result of the huge challenges we face around social distancing. Everyone who can work from home must continue to do so for some time to come. The emergency

measures included in our major strategic London Streetspace programme will help those who have to travel to work by fast-tracking the transformation of streets across our city.

Many Londoners have rediscovered the joys of walking and cycling during lockdown and, by quickly and cheaply widening pavements, creating temporary cycle lanes and closing roads to through traffic we will enable millions more people to change the way they get around our city.

I urge the Government and boroughs to work with us to enable Londoners to switch to cleaner, more sustainable forms of transport - and reduce the pressure on other parts of our transport network – once the lockdown is eased."

Updated Lines on Household Waste & Recycling Centres (6th May 2020)

London Councils have updated their lines in response to prospective plans to re-open HWRC's.

"London boroughs are making plans to reopen household waste and recycling centres (HWRCs) as soon as possible.

The safety of Londoners and borough workers is paramount, which is why HWRCs are unlikely to reopen at the same time or run at full capacity due to social distancing guidelines and pressures on staff and local roads. Boroughs may also introduce new measures such as pre-booked timeslots where necessary.

We ask Londoners to help us keep these services running smoothly by only visiting a HWRC when it is absolutely essential, planning visits carefully by checking borough websites, practicing social distancing and good hygiene while on site and treating all HWRC workers with respect."

Rapid Response Unit Support (6th May 2020)

In response to a parliamentary question on the deployment of the 77 brigade, the Ministry of Defence has issued the following line:

"A small MOD team, including members of 77 Brigade, is supporting the Cabinet Office's Rapid

Response Unit (RRU), in its efforts to tackle disinformation around COVID-19. The military staff operate under the same rules and procedures as civil servants.

The RRU is tackling a range of harmful narratives online, from purported 'experts' issuing dangerous misinformation to criminal fraudsters running phishing scams. As the Rapid Response Unit is housed within the Cabinet Office, further queries should be directed to the Cabinet Office team."
