Daily Mortality Figures (London)

As of 1st May 2020, the SCG daily briefing now takes account of mortalities that do not have a positive test result, but where COVID-19 is documented as a direct or underlying cause of death, dated back to the 24^{th} April.— for more information on this updated methodology, please visit here.

New Government Guidance (1st June 2020)

The Government has issued new guidance over the weekend (31st May 2020) in relation to social distancing. This includes new regulations stipulating the activities you can now do outside of the home, with continued emphasis to Stay Alert and remain at home as much as practicable.

Changes to Furlough Scheme (29th May 2020)

The Chancellor of the Exchequer, Rishi Sunak, announced on Friday an update to the government's 'Job Retention Scheme'. In his announcement, it was confirmed that the Self-Employment Income Support Scheme has been extended. Other updates included a new pathway for re-introducing furloughed employees to part-time work and changes to the ratio of government/employer contributions to furloughed staff.

BAME Risk Assessments (1st June 2020)

The Mayor of London, Sadiq Khan, has today announced that Black, Asian and minority ethnic (BAME) staff across the Greater London Authority family will have access to risk assessments as part of measures to help those disproportionately affected by Covid-19.

The risk assessments – which will be open to those working across the GLA family, including Transport for London, The Metropolitan Police and London Fire Brigade – will consider the physical and mental health needs of all vulnerable staff, including BAME, older and those with pre-existing conditions.

The range of support is being offered in response to increasing evidence showing that Black, Asian and minority ethnic people are disproportionately likely to be impacted by Covid-19.

The Mayor of London has confirmed his commitment to helping the capital's construction and housing sector bounce back from Coronavirus by approving a £50m loan facility for Mount Anvil. The funding will enable the London centric housing developer to accelerate the purchase of new sites and deliver an increased number of new quality homes.

Travel Advice for Schools (1st June 2020)

Transport for London (TfL) has issued advice for headteachers, parents and guardians across London on how they can play a part in controlling the coronavirus as schools gradually begin to reopen.

The Government's coronavirus recovery strategy sets out expectations that children are able to return to early years settings, Reception, Year 1 and Year 6, from 1st June. The TfL advice works alongside Government guidance on safe travel, helping schools, parents and guardians to understand the specific challenges for London's transport network during the pandemic and how to keep people safe as pupils start to return to school.
